THE PERSONAL DATA PROTECTION POLICY ADOPTED AT "M.B.S. TRADE" AD

Welcome,

We are, indeed, very happy that you have chosen to visit the site kept by NFT CREDO Collectible Sports Goods We are concerned about the privacy of your personal information and the data you share with us which is why we would like you to know exactly how we use and store this information. "M.B.S. TRADE" AD, takes care of the confidentiality of personal data and in its business it has implemented the best available practices in full conformity with the applicable laws and regulations on personal data protection, including the EU General Data Protection Regulation ("GDPR").

How to use the website

The present privacy policy describes the information we collect from you, the manner of its storage by "M.B.S. TRADE" AD, and the way it is processed within the European Union, as described further below.

The website - and all related current and future projects, such as auctions, events and publications by NFT CREDO Collectible Sports Goods - serves to provide products, content and services to professional sportsmen and the general public and are not intended for individuals below the age of 18. We do not intentionally, and knowingly, collect and store any personal information regarding such individuals.

If you are a citizen of the European Union (EU), please note that there are many provisions in the present privacy policy which are applicable to you alone.

What information do we collect about you

The information you provide us with is derived and collected from the registration forms which you complete or send to us via the e-mail or - for instance - when registering an account with us. This information may include your first and last name, e-mail address, telephone number and other information related to the service for which your data is collected and processed.

We collect any/all information contained in the correspondence we exchange between each other, through the contact form on the website and the various emails, phone calls and so on.

Information about you is also collected when you visit our website and depending on how you use it. This may include your IP address, device information, browser type, source of referral, duration of a given visit, operating system, number of page views, which pages you have visited and other such information. It can also be collected from third party providers of website analysis services on our behalf and/or through cookies. We also use cookies and pixels in our emails to track the number of deliveries and page openings, the results from which are stored against your email address and account. For more information about cookies, please see our "cookie" policy.

How do we get this information

We may collect your personal data when you register to receive information about current and upcoming auctions, news, or other services offered by "NFT CREDO Collectible Sports Goods" or its partners - third parties, such as: publications, subscriptions, newsletters, memberships, official announcements, etc.

How do we protect your personal data?

"M.B.S. TRADE" AD maintains the practice of permanent precautionary measures, including technical and organizational security activities in order to protect your personal data from loss, misuse, unauthorized use, access, unintentional disclosure, alteration and destruction.

On a permanent basis we update and test the security aspects of our work and restrict access to your personal data only to the individuals, who have to have it in order to be able to provide the content of the services offered on the NFT CREDO Collectible Sports Goods.

Storing your personal data

We can store your personal information on our own, local "M.B.S. TRADE" AD servers, or employ other internal technologies. None of your personal data is shared with any third parties.

Your personal data and the related legislative grounds for using it

Depending on the relationship we have developed with you, we may use your personal information for the purposes listed below. Before providing us with such data, however, and whenever necessary we shall provide you with more specific information on exactly how we will use the information and will provide you with a link to the resent privacy policy.

When and how do we share your personal information with others

We do not share your personal information with third physical or legal persons.

How long do we keep your personal data

We retain your personal information for the duration of your business relationship with us and store it only for as long as it is vitally necessary for achieving the objective for which we are using it, unless - off course - we have received your consent to use the data for some other or similar purpose.

What rights and preferences can you enjoy

In the event that you inform us of you wish that the personal data we have of you has to be deleted or that you no longer wish to maintain a communication with us for any marketing purpose, or should you wish to restrict the processing of your personal data by NFT CREDO Collectible Sports Goods in some other way, we may retain some basic information in order to avoid sending unsolicited material in the future and to keep your requests, and our responses to them, in our archives.

Confirmation of your personal data

Personal data protection measures introduced by "M.B.S. TRADE AD.

"M.B.S. TRADE" AD has introduced measures for the effective protection of the processed personal data and the possibility to exercise the rights of data subjects provided for in REGULATION 2016/679, by adopting internal personal data protection rules. Stringent procedures are in place regarding the means of communication in cases of submitted complaints, portability/transferability of the data, transparency in the processing of personal information, the management of requests submitted by subjects, for obtaining consent, notification of security breaches, storage and destruction of documents and many other technical measures taken to ensure the security of personal data.

Access to your personal data within our organization is available only to those individuals whose employment functions require access to the data in order to be able to carry out the activities for which the data were collected and processed in the first place. We include contractual clauses for the confidentiality of the data we use in all of the contracts we conclude with employees and third parties to whom we assign the processing of your personal data.
